The Madison Area Municipal Stormwater Partnership (MAMSWaP) is offering a \$30 reimbursement for anyone who purchased and installed a rain barrel through Dane County in 2024 (up to four rain barrels per household). You are eligible to apply if you meet the following:						
 □ I purchased a rain barrel through Dane County in 2024. □ The property where the rain barrel was installed is located within a MAMSWaP Community (see list of communities on the second page of this form). □ I installed the rain barrel on a downspout and applied for reimbursement within 60 days from the date of purchase. □ I have not received more than four reimbursements from this program.
