Plant Dane Pick Up- Plant Dane pick up dates were May 21<sup>st</sup> 8-11AM (order #s 3394-3828) and May 25<sup>th</sup> 4-7PM (order #s 3829-4261). All went well with drive-thru pick up at the Dane County Land and Water Resources Dept. Building off Fen Oak Dr. on Sat. and at the Dane County Parks Facility Building off Robertson Rd. on Wed.

<u>Illicit Discharge Training Recap-</u>Rick Wenta and Claudia Guy taught the Illicit Discharge Training on June 14. Twenty-four people attended. Training covered Dane County's new illicit discharge ordinance, as well as outfall screening. Some key takeaways are summarized below.

- Illicit discharge ordinance:
  - If a municipality receives an illicit discharge report and would like some assistance with it, they
    can submit the report to the County's new reporting website:

  - o If the County receives an illicit discharge report directly through our website, we will work with the municipality on next steps. It's important for us to have the MS4 municipal contact on file especially if the illicit discharge reaches the MS4, or if utility maps (typically storm or sanitary) are needed. - Outfall Screening
  - We purchased a Hach Stormwater Test Kit for use by MAMSWaP communities. We'll keep the kit at our Fen Oak office (5201 Fen Oak) and MAMSWaP communities can borrow the test kit if they see flowing water during an outfall inspection and suspect that it may be an illicit discharge. Test kit has been ordered, and we are currently still waiting for it to arrive.

<u>Adopt a Storm Drain Program</u>- The City of Middleton and Village of Cross Plains were both recently added to the program. Since late July, 207 storm drain have been adopted by 92 adopters. In order to participate municipalities must:

- Provide an electronic file with storm drain locations,
- have a designated staff member who will work with Christal on cleaning kit distribution and act as the local liaison to the program and
- use provided outreach materials to promote the program locally.

<u>Habitat for Humanity (H4H) Rain Garden Project Postponed</u>- The rain garden project at Tenneyson Ln. on the north side of Madison has been postponed until fall due to some grading and landscaping delays at the site this spring. Hoping to create time-lapse video of the process to post on the web site once completed.

<u>Native Garden Signs</u>- MAMSWaP has three <u>new native garden signs</u> available <u>free</u> of charge to groups that are participating in our Free Native Plants for School and Community Groups program and to MAMSWaP partners. These are meant to be educational signs to help promote native gardens, downspout gardens and rain gardens. Signs are 10"x12" metal signs and come with a U-channel or wooden post. Storm Drain Mural Update- All new murals have been painted. We still have one repaint in Madison and one carry-over mural from 2021 to paint in Fitchburg. Plans for 2023, our current artist, Sonya Sankaran, is interested in partnering with us next year. We'll accept up to five new mural applications and five repaints for 2023. If you have a mural that was painted in 2018-2020 that is looking a little worn and you'd like it repainted, contact Christal. Applications for 2023 will be available in Dec. 2022.

Rain Barrel Program- Dane County/MAMSWaP is selling 50 gallon rain barrels at a discounted rate of \$74 (typically retails for ~\$150). This program is open to all Dane County residents and businesses. Residents that live in a MAMSWaP community are eligible to apply for an additional \$30 reimbursement. Rain barrels are available for pickup at the Middleton Recycling Center and Deforest Yardwaste Collection Site during normal operating hours for those facilities from April-September. The program has been extremely popular with 250 rain barrels sold since April and 63 people submitting forms for reimbursements from MAMSWaP communities.

Stewards Program where participants learned about how our local water system works, the human impact on water and gain knowledge and skills about practical actions to conserve, protect, restore, and advocate for our local water systems. To fully complete the program and receive the water steward certification, participants have to complete a water project with the support of Sustain Dane and partners by October. MAMSWaP/Dane County stormwater programs and tools were shared during two required virtual sessions on June 14<sup>th</sup> and June 21<sup>st</sup>. Feedback from the first session was positive. Sustain Dane will be following up with participants to encourage them to choose and complete projects.

- 63 participants registered
- 57 attended first and second sessions
